Director's Message

In compliance with the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act (Clery Act), this document contains information about campus fire safety practices and standards of the College. In addition, fire statistics for the last three calendar years are included in this report.

Campus Safety, in conjunction with the Office of Campus Life and Facilities Management, work together to maintain a safe campus environment with respect to fire safety. The College utilizes a Simplex Fire Detection and Alarm System. College units work closely with Standish Fire-EMS Division and various service providers to ensure that all required inspections, operational tasks, and preventive maintenance are performed in accordance with rules of the State Fire Marshal and State adopted NFPA standards.

I encourage you to read this document and to know and use this important safety information to enhance your learning, living and working experience at Saint Joseph's College.

Fire Safety Policies & Practices

1. Without expressed consent from the College and Campus Safety, fires of any size are not allowed anywhere on campus. Residence Life Staff are available to assist in the evacuation and overall safety of the residence halls.
2. During the academic year, Safety, Health and Fire inspections will be conducted. Campus Life may partner with Facilities and Standish Fire to conduct these inspections. These groups walk through the buildings and may check a resident's room in order to evaluate and uphold health and safety standards. Violations of fire code could result in a fine from the Standish Fire Department.
3. Fire equipment (e.g. smoke detectors, pull alarm stations and fire extinguishers) shall be installed in each resident hall, and annual fire drills and safety training sessions are conducted. The Standish Fire Department conducted dormitory fire drills on 09/27/2022 to promote dorm fire safety, efficient evacuation and fire prevention strategies. Attendance is taken at the evacuation location to ensure all student occupants are accounted for.
4. Any time a fire alarm sounds, all students must leave the building. Failure to evacuate during any fire alarm will result in a \$150 fine and any additional sanctions. Students who have multiple offenses may result in increased fines and more severe disciplinary action.
5. Appliances that require high heat are not permitted in the residence halls. Open burner items or items with hot plates are not permitted.
6. Candles and any item that could be burned (e.g. incense/oil lamps) are not permitted in the residence halls. This includes candles for decoration or unburned candles.
7. Power strips with a built-in circuit breaker and three-prong extension cords are allowed in the residence halls. Per the Standish Fire Code, any other extension cords (two-pronged) or non-grounded strips are prohibited.
8. Certain room decorations do pose fire hazards (fishnet, incense, etc.) and are not permitted in the halls. Open bulb lighting is not approved. Additionally, no more than 50% of wall space can be covered and no electrical outlets/fixtures can be covered due to fire regulations. No items may be hung from the ceiling or from/near sprinkler pipes.
9. Any individual or group involved in tampering with fire or safety equipment (smoke detectors, emergency phones, sprinkler systems, pull stations, etc.) may be immediately removed from

campus housing. If the person(s) responsible cannot be identified, the residents of the floor/area may be charged through the damage billing process.

10. Fire Evacuation

A. When the fire alarm sounds:

1. Always assume that it is a real fire whenever an alarm sounds.

DO NOT IGNORE AN ALARM!

2. As you leave your room, check the door and handle to see if they are hot.
3. If the door/handle is *not* hot:
 - Take your coat and shoes with you
 - You must leave your room
 - Follow the designated evacuation route.
4. If the door/handle *is* hot:
 - Stay in your room. It only takes a few minutes for the fire department to arrive.
 - Place a wet towel rolled up against the crack at the bottom of the door.
 - Hang a sheet out of your window; leave the window open slightly to allow good air in and bad air out.
 - Stay close to the floor, as smoke will rise to fill up the top of the room. Above all, **REMAIN CALM.**

B. If you see a fire:

1. Pull the fire alarm nearest you.
2. Leave the building via the safest evacuation route.
3. Once outside, immediately report to the designated evacuation location.

C. Other important information:

1. Be knowledgeable of all evacuation routes out of the building.
2. Learn where the fire alarms are on your floor.
3. **YOU ARE RESPONSIBLE FOR YOUR OWN SAFETY DURING A FIRE ALARM.** Leave the building immediately. Do not wait to be told.

Emergency Situations

FIRE

- **EMERGENCY ACTION: EVACUATE**
- Feel for heat on all doors prior to opening- if hot- **DO NOT OPEN**
- If smoke is present, cover nose and mouth with clothing, stay as low to the ground as possible and exit
- **DO NOT USE ELEVATOR**
- Proceed to fire alarm gathering location (see map)

SEVERE WEATHER

- **EMERGENCY ACTION: SHELTER-IN-PLACE**
- Move to an interior room or hallway on the lowest floor and get beside a sturdy piece of furniture
- Stay away from windows. **DO NOT OPEN** windows
- Remain in safe area until danger has passed

ACTIVE SHOOTER

- **EMERGENCY ACTION: SECURE-IN-PLACE**
- Proceed to a room that can be secured, shut and lock the door, close windows, get down on the floor where you are not visible
- Silence your devices. **DO NOT TURN YOUR CELL PHONE OFF**
- Immediately call Campus Safety 207-893-7911
- If the shooter is in your area, remain calm, follow orders, and call Campus Safety when it is safe to do so

MEDICAL

- Immediately call Campus Safety 207-893-7911
- **DO NOT** move the seriously injured
- Provide CPR/Basic First Aid only if trained to do so

Emergency Actions

SECURE-IN-PLACE

- Ordered when necessary to place a locked door or barricade between you and the associated danger
- If outside seek cover in the nearest unlocked building
- If the buildings have been locked, continue to move away from danger, seek cover, move to another building, or exit campus if it is safe to do so
- Once inside, find an interior room, lock/barricade doors
- To minimize vulnerability, turn off lights, silence phones, draw blinds, and move away from windows
- Await further instruction from emergency personnel
- Do not exit until "All Clear" is received
- Be silent and still

SHELTER-IN-PLACE

- Ordered when protection is necessary from hazardous weather
- Immediately seek shelter inside the closest sturdy building. Do not wait until you physically see severe weather event to react
- Once inside, stay away from windows, and unsecured objects that may fall
- Seek shelter in interior rooms and corridors
- Do not use elevators
- Await further instruction from emergency personnel
- Do not exit until "All Clear" is received

EVACUATE

- Ordered when people must exit the building due to unsafe circumstances
- Take with you only important personal items such as your keys or phone
- Follow instructions from emergency personnel
- Check doors for heat before opening. Do not open if it feels hot
- Walk - do not run
- Head to your assembly point, unless otherwise instructed
- Keep roadways and walkways clear for emergency vehicles
- Do not return to building until notified that it is safe to do so

Fire Detection and Suppression Systems

All residential buildings are protected by automatic sprinkler systems and are equipped with fire detection and alarms systems. Residential buildings are also equipped with fire extinguishers in accordance with the requirements of the construction and/or fire safety code.
